

In making a continuation award, the Secretary also considers whether the grantee is operating in compliance with the assurances in its approved application, including those applicable to Federal civil rights laws that prohibit discrimination in programs or activities receiving Federal financial assistance from the Department.

### Proposed Re-Issuance of National Pollutant Discharge Elimination System General Permit for Wastewater Discharges Associated With Drinking Water Production Located in the EPA Region 8 Indian Country and Lands of Exclusive Federal Jurisdiction

**AGENCY:** Environmental Protection Agency (EPA).

**ACTION:** Notice of availability for comment.

**SUMMARY:** The EPA Region 8 is requesting comments on the draft 2025 National Pollutant Discharge Elimination System (NPDES) drinking water general permit (DWGP) for wastewater discharges associated with drinking water treatment plants. The DWGP will authorize wastewater discharges from drinking water facilities located in Indian country in the EPA Region 8 in accordance with the terms and conditions described therein. This is the first reissuance of the DWGP. EPA proposes to issue the permit for five (5) years and is seeking comment on the draft permit.

**DATES:** Comments must be received, in writing, on or before July 18, 2025.

##### I. Background

The Drinking Water General Permit (DWGP) contains requirements similar to an individual permit and will authorize the discharge of process wastewater in accordance with the terms and conditions described therein.
