AGENCY: Bureau of Safety and Environmental Enforcement, Interior.

ACTION: Notice of Intent to Transfer Pipeline Ownership and Request for Submissions of Competing Interest.

SUMMARY: The Bureau of Safety and Environmental Enforcement (BSEE) is considering whether to authorize the transfer of ownership of certain pipelines in the Gulf of America (GOA).

SUPPLEMENTARY INFORMATION:

Background: BSEE received a written request to acquire certain pipeline segments in the GOA located on rights-of-way (ROW) that have been relinquished pursuant to 30 CFR 250.1019. The associated pipeline segments were relinquished by the ROW holder on March 12, 2024. The party requesting to acquire the pipelines is not a prior ROW holder for the segment.

BSEE has determined that, pursuant to 30 CFR 250.1010(h), the Outer Continental Shelf (OCS) pipeline and any related infrastructure are the property of the United States and may be transferred to private parties. BSEE received the request from a private party seeking to acquire the pipeline segment from the United States, as set forth in the table below:
