POLICY JUSTIFICATION

Morocco - F-16C/D Block 50/52 Aircraft

The Government of Morocco has requested a possible sale of 40 LAU-129A Launchers; 20 AGM-65D MAVERICK Missiles; 4 AGM-65D MAVERICK Training Missiles; 4 AGM-65H MAVERICK Training Missiles; 60 Enhanced GBU-12 PAVEWAY II Kits; 28 M61 20mm Vulcan Cannons; 28 AN/ARC-238 Single Channel Ground and Airborne Radios with HAVEQUICK I/II or SATURN I/II; Also included: 1 Ground Based Simulator, 40 LAU-118A missile rails, 6 AN/AAQ-33 SNIPER Targeting Pods with Ground Station, 16 Air Combat Maneuvering Instrumentation (ACMI) Pods, 4 ACMI Ground Stations, 8 Joint Mission Planning Systems, 2 Remote Operated Video Enhanced Receivers, 30 AN/ALR-93 Radar Warning Receivers, 30 AN/AVS-9 Night Vision Goggles, containers, bomb components, support equipment, repair and return, spares and repair parts, publications and technical documentation, personnel training and training equipment, U.S. Government and contractor technical, engineering, and logistics support services, and other related elements of logistics support. The estimated cost is \$187 million.

The proposed sale will contribute to the foreign policy and national security objectives of the United States by enhancing Morocco's capacity to support U.S. efforts in the Overseas Contingency Operations, as well as supporting Morocco's legitimate need for its own self-defense. Morocco is one of the most stable and pro-Western of the Arab states, and the U.S. remains committed to a long-term relationship with Morocco.

The proposed sale will allow the Moroccan Air Force to modernize its aging fighter inventory, thereby enabling Morocco to support both its own air defense needs and coalition operations. Morocco is a Major Non-NATO ally. Delivery of this weapon system will greatly enhance Morocco's interoperability with the U.S. and other NATO nations, making it a more valuable partner in an increasingly important area of the world.

The proposed sale of this weapon system will not alter the basic military balance in the region.

Item No. vii****(vii) Sensitivity of Technology:**

1. The AGM-65G/H MAVERICK air-to-ground missile has an overall classification of Secret. The Secret aspects of the Maverick system are tactics, information revealing its vulnerability to countermeasures, and counter-countermeasures. Manuals and technical documents, which are necessary for operational use and organizational maintenance have portions that are classified Confidential. Performance and operating logic of the countermeasures circuits are Secret.

2. The PAVEWAY II/III series of laser guided bombs consists of a guidance kit that converts existing unguided free-fall bombs into precision-guided "smart" munitions. At the core of each PAVEWAY II/III Munition Kit is a dumb bomb. A laser guidance kit is integrated with each dumb bomb to add the requisite level of accuracy. The kit consists of a computer-controlled group at the front end of the weapon and an airfoil group at the back. When a target is illuminated by a laser, either airborne or ground-based, the guidance fins react to signals from the control group and steer the weapon to the target. This precision-guided munition offers improved accuracy over free-fall bombs, thus providing the potential for reduced collateral damage.

3. The AN/AAQ-33 SNIPER targeting system is Unclassified but contains technology representing the latest state-of-the-art in several areas. Information on performance and inherent vulnerabilities is classified Secret. Software (object code) is classified Confidential. Sensitive elements include the forward looking infrared (FLIR) sensors, Laser Pulse Interval Modulation (PIM) and doublet coding, and the AGM-65 Missile Boresight Correlator (MBC), and ECCM features that increase capability in a jamming environment. The SNIPER system to be released will not include laser PIM, laser doublet coding, or the Lockheed Martin (LM)-proprietary XR image processing algorithm (no extended range capability).

4. If a technologically advanced adversary were to obtain knowledge of the specific hardware or software in this proposed sale, the information could be used to develop countermeasures which might reduce weapon system effectiveness or be used in the development of systems with similar or advance capabilities.

SUMMARY: On August 3, 2009, the Deputy Under Secretary of Defense (Plans), Performing the Duties of the Under Secretary of Defense (Personnel and Readiness), signed a memorandum to the Director, Department of Defense Education Activity, designating for enrollment on a space-available, tuition-free basis, classes of dependents of military and diplomatic personnel whose nations participated in the Partnership for Peace (PfP) Program in Brussels and Mons, Belgium; Naples, Italy; London, United Kingdom; Brunssum, the Netherlands; and Oberammergau, Germany, prior to gaining status as full members of NATO during the period between January 2009 and January 2014. Subject to the availability of space, this waiver may be applied for the duration of the sponsor's tour not to exceed a total of three years for each eligible dependent. This class waiver is effective immediately.

Most of the Corps of Engineers civil works survey information is collected for very unique circumstances, such as visitor information at Corps recreation areas or flood damage information related to the Corps evaluation procedures. Much of this information is required to be very current and must be updated every one to two years.
