**SUMMARY:** The U.S. Department of State's Office of Economic Sanctions

Policy and Implementation (SPI) is publishing the names of two persons and one vessel that have been removed from the List of Specially Designated Nationals and Blocked Persons (SDN List) maintained by the Office of Foreign Assets Control (OFAC) and are consequently no longer subject to the prohibitions imposed April 15, 2021, "Blocking Property With Respect To Specified Harmful Foreign Activities of the Government of the Russian Federation."
