Filing Dates for the Tennessee Special Election in the 7th Congressional District

AGENCY: Federal Election Commission. **ACTION:** Notice of filing dates for Special Election.

SUMMARY: Tennessee has scheduled special elections on October 7, 2025, and December 2, 2025, to fill the U.S. House of Representatives seat in the 7th Congressional District vacated by Representative Mark Green. Committees required to file reports in connection with the Special Primary Election on October 7, 2025, shall file a 12-day Pre-Primary Report. Committees required to file reports in connection with both the Special Primary and Special General on December 2, 2025, shall file a 12-day Pre-Primary, a 12-day Pre-General and a 30-Day Post-General Report.

All principal campaign committees of candidates who participate in the Tennessee Special shall file a 12-day Pre-Primary Report on September 25, 2025; a 12-day Pre-General Report on November 20, 2025, and a 30-day Post-General Report on January 1, 2026. Unauthorized Committees (PACs and Party Committees)

Political committees not filing monthly are subject to special election reporting if they make previously undisclosed contributions or expenditures in connection with the Tennessee Special Primary or Special General Election by the close of books for the applicable report(s). (See charts

below for the closing date for each report.)

Committees filing monthly that make contributions or expenditures in connection with the Tennessee Special Primary or Special General Election will continue to file according to the monthly reporting schedule.

Disclosure of Lobbyist Bundling Activity

FEDERAL TRADE COMMISSION

Granting of Requests for Early Termination of the Waiting Period Under the Premerger Notification Rules

Section 7A of the Clayton Act, 15 U.S.C. 18a, as added by Title II of the Hart-Scott-Rodino Antitrust Improvements Act of 1976, requires persons contemplating certain mergers or acquisitions to give the Federal Trade Commission and the Assistant Attorney General advance notice and to wait designated periods before consummation of such plans. Section 7A(b)(2) of the Act permits the agencies, in individual cases, to terminate this waiting period prior to its expiration and requires that notice of this action be published in the **Federal Register**.

The following transactions were granted early termination—on the dates indicated—of the waiting period provided by law and the premerger notification rules. The listing for each transaction includes the transaction number and the parties to the transaction. The grants were made by the Federal Trade Commission and the Assistant Attorney General for the Antitrust Division of the Department of Justice. Neither agency intends to take any action with respect to these proposed acquisitions during the applicable waiting period.
