#### Abstract of Information Available

Human remains representing, at least, two individuals have been identified. No associated funerary objects are present. The human remains were recovered by a local collector from archeological site 34JK18 in Jackson County, Oklahoma before 1990. These human remains were brought into the

Museum of the Great Plains along with artifacts in 2017; OTAO took control of the human remains at this time. There is no known presence of any potentially hazardous substances used to treat any of the human remains.

#### Cultural Affiliation

Based on the information available and the results of consultation, cultural affiliation is reasonably identified by the geographical location or acquisition history of the human remains described in this notice.

#### Determinations

The OTAO has determined that:

- The human remains described in this notice represent the physical remains of two individuals of Native American ancestry.
- There is a connection between the human remains described in this notice and the Wichita and Affiliated Tribes (Wichita, Keechi, Waco, & Tawakonie), Oklahoma.

#### Requests for Repatriation

Written requests for repatriation of the human remains in this notice must be sent to the authorized representative identified in this notice under

Repatriation of the human remains described in this notice to a requestor may occur on or after May 30, 2025. If competing requests for repatriation are received, the OTAO must determine the most appropriate requestor prior to repatriation. Requests for joint repatriation of the human remains are considered a single request and not competing requests. The OTAO is responsible for sending a copy of this notice to the Indian Tribes and Native Hawaiian organizations identified in this notice.

**SUMMARY:** In accordance with the Native American Graves Protection and Repatriation Act (NAGPRA), the University of California, Berkeley has completed an inventory of human remains and associated funerary objects and has determined that there is a cultural affiliation between the human remains and associated funerary objects and Indian Tribes or Native Hawaiian organizations in this notice.

#### Abstract of Information Available

Based on the information available, ancestral remains representing at least 48 individuals have been reasonably identified. The two lots of associated funerary objects include faunal remains.

In 1948, the ancestral remains were donated by the Gila Pueblo Museum in Arizona to the University of California, Berkeley Museum of Anthropology (now the Phoebe A. Hearst Museum of Anthropology). The ancestors were removed between 1930 and 1948 by Jeremiah B. Lillard, Sacramento Junior College, and various other individuals from one or more of the following sites: CA-SAC-16, CA-SAC-43, CA-SAC-60, CA-SAC-66, CA-SAC-107, CA-SAC-121, CA-SAC-126, CA-SAC-151, CA-SAC-165, and Dalton in Sacramento County, CA and CA-SJO-56 in San Joaquin County, CA.

Collections and collection spaces at the Phoebe A. Hearst Museum of Anthropology were treated with substances for preservation and pest control, some potentially hazardous. No records have been found to date at the Museum to indicate whether or not chemicals or natural substances were used prior to 1960.

### Cultural Affiliation

Based on the information available and the results of consultation, cultural affiliation is reasonably identified by the geographical location or acquisition history of the human remains and associated funerary objects described in this notice.

### Determinations

The University of California, Berkeley has determined that:

- The human remains described in this notice represent the physical remains of, at minimum, 48 individuals of Native American ancestry.

- The two lots of objects described in this notice are reasonably believed to have been placed intentionally with or near individual human remains at the time of death or later as part of the death rite or ceremony.

- There is a reasonable connection between the human remains and associated funerary objects described in this notice and the Buena Vista Rancheria of Me-Wuk Indians of California; California Valley Miwok Tribe, California; Chicken Ranch Rancheria of Me-Wuk Indians of California; Ione Band of Miwok Indians of California; Jackson Band of Miwok Indians; Picayune Rancheria of Chukchansi Indians of California; Santa Rosa Indian Community of the Santa Rosa Rancheria, California; Shingle Springs Band of Miwok Indians, Shingle Springs Rancheria (Verona Tract), California; Table Mountain Rancheria; Tejon Indian Tribe; Tule River Indian Tribe of the Tule River Reservation, California; Tuolumne Band of Me-Wuk Indians of the Tuolumne Rancheria of California; United Auburn Indian Community of the Auburn Rancheria of California; and the Wilton Rancheria, California.

### Requests for Repatriation

Written requests for repatriation of the human remains and associated funerary objects in this notice must be sent to the authorized representative identified in this notice under **ADDRESSES**. Requests for repatriation may be submitted by:

1. Any one or more of the Indian Tribes or Native Hawaiian organizations identified in this notice.

2. Any lineal descendant, Indian Tribe, or Native Hawaiian organization not identified in this notice who shows, by a preponderance of the evidence, that the requestor is a lineal descendant or a culturally affiliated Indian Tribe or Native Hawaiian organization.

Repatriation of the human remains and associated funerary objects in this notice to a requestor may occur on or after May 30, 2025. If competing requests for repatriation are received, the University of California, Berkeley must determine the most appropriate requestor prior to repatriation. Requests for joint repatriation of the human remains and associated funerary objects are considered a single request and not competing requests. ### Abstract of Information Available

Associated funerary objects have been identified totaling 1,182 catalog entries representing lithics, paleobotanicals, soil samples, faunal remains, shell, shell beads, light fraction samples, ground stone, baked clay, and post-contact historic artifacts. Of the 1,182 associated funerary objects, eight catalog numbers are missing and Caltrans and Sonoma State University (SSU) continue to look for them. These collections, known as the "Gleason Beach Collections," are from Sonoma County along Highway 1 and are housed at SSU. The collections are the result of Caltrans project-delivery related excavations at the following sites between 1977 and 2020: CA-SON-346 (Acc. 2013-024); CA-SON-347 (Acc. 77-016, 2013-028, 2019-061, 2020-005, and an unaccessioned 2003 collection); CA-SON-2585 (Acc. 2013-026); CA-SON-2612 (Acc. 2013-027); and CA-SON-465/H (Acc. 2013-025). There are no known/documented potentially hazardous substances used to treat any of the cultural items. As a result of consultation, the Kashia Band of Pomo Indians of the Stewarts Point Rancheria deferred to the Federated Indians of Graton Rancheria.

### Cultural Affiliation

Based on the information available and the results of consultation, cultural affiliation is clearly identified by the information available about the associated funerary objects described in this notice.

### Determinations

Caltrans has determined that:

- The 1,182 objects described in this notice are reasonably believed to have been placed intentionally with or near individual human remains at the time of death or later as part of the death rite or ceremony.
