1. *Title:* OFAC Application for the Release of Blocked Funds.

*OMB Number:* 1505-0170.

*Description:* Transactions prohibited pursuant to the Trading With the Enemy Act, 50 U.S.C. 4301-4341, the International Emergency Economic Powers Act, 50 U.S.C. 1701 *et seq.*, and other authorities may be authorized by means of specific licenses issued by OFAC. Such licenses are issued in response to applications submitted by persons whose property and interests in property have been blocked or who wish to engage in transactions that would otherwise be prohibited. The OFAC Application for the Release of Blocked Funds, which provides a standardized method of application for all applicants seeking the unblocking of funds, is available in electronic format on OFAC’s website. By obviating the need for applicants to write lengthy letters to OFAC, this form and the electronic portal reduce the overall burden of the application process. Applications to OFAC for the release of blocked funds are strongly encouraged to be made via the electronic licensing portal here: <https://home.treasury.gov/policy-issues/financial-sanctions/ofac-license-application-page>.

2. *Title:* Persons Providing Travel and Carrier Services to Cuba.

*Form Number:* Section 515.572 does not specify any particular form of recordkeeping.

*Description:* Requirements to retain records are codified in § 515.572 of the Cuban Assets Control Regulations, 31 CFR part 515 (the “Regulations”). Persons subject to U.S. jurisdiction who provide authorized travel or carrier services related to Cuba are required to maintain for at least five years from the date of the transaction a certification from each customer indicating the name and address of each customer and the section of the Regulations (in the case of generally licensed travel), or the specific license number, that authorizes the person to travel to Cuba.

The records covered by this information collection must be provided on request to the U.S. Department of the Treasury, and support OFAC’s implementation of its compliance and enforcement programs pursuant to the Regulations.

*Estimated Number of Respondents:* 565,000 respondents per year.

The information collected under § 36.4333 is used by VA to ensure lenders and servicers who participate in VA’s Loan Guaranty program follow statutory and regulatory requirements, such as those

relating to credit information, loan processing requirements, underwriting standards, servicing requirements, and other applicable laws, regulations and policies. VA also uses data collected under this authority to provide annual feedback to lenders, through the Lender Scorecard, on certain loan characteristics such as interest rate, fees and charges, audit results, etc., as compared to the national average of all VA lenders.

*Abstract:* This Paperwork Reduction Act (PRA) submission seeks renewal without changes of Office of Management and Budget (OMB) approval No. 2900-0422 for five collections of information for the Department of Veterans Affairs Acquisition Regulation (VAAR) clauses, as follows:

- Clause 852.232-70, Payment Under Fixed-Price Construction Contracts (without NAS-CPM), requires construction contractors, without NAS-

CPM, to submit a schedule of costs for work to be performed under the contract.

- Clause 852.232-71, Payment Under Fixed-Price Construction Contracts (including NAS-CPM), requires construction contractors, including NAS-CPM, to submit a schedule of costs for work to be performed under the contract.

- Clause 852.236-72, Performance of Work by the Contractor, requires contractors awarded a construction contract containing Federal Acquisition Regulation (FAR) clause 52.236-1, Performance of Work by the Contractor, to submit a statement designating the branch or branches of contract work to be performed by the contractor’s own forces.

- Clause 852.236-80, Subcontracts and Work Coordination, requires construction contractors, on contracts involving complex mechanical-electrical work, to furnish coordination drawings showing the manner in which utility lines will fit into available space and relate to each other and to the existing building elements.

- Clause 852.243-70, Construction Contract Changes-Supplement, requires contractors to submit cost proposals for changes ordered by the contracting officer or for changes proposed by the contractor.
