

objectives is to safeguard loan security until the loan is repaid. When a borrower enters into the mortgage agreement with the Agency, all current and future capital assets of the borrower are ordinarily mortgaged or pledged to the Federal Government as security for Agency loans. The Agency's policy on sales of capital assets requires that the sale meet several requirements including the following: (1) the selling price shall be greater than or equal to the fair market value; and (2) the sale shall not jeopardize the repayment of the Agency's loan.

The selling of assets reduces the security and increases the risk to the government. RUS Form 369 allows the borrower to seek agency permission to sell some of its assets. The form collects detailed information regarding the proposed sales of a portion of the borrower's systems. RUS electric utility borrowers complete this form to request RUS approval in order to sell capital assets when the fair market value exceeds 10 percent of the borrower's net utility plant.

*Estimate of Burden:* Public reporting burden for this collection of information is estimated to average 2.074 hours per response.

*Respondents:* Nonprofit corporations and institutions of higher education.

*Estimated Number of Respondents:* 35.

*Estimated Number of Responses per Respondent:* 2.31.

*Estimated Number of Responses:* 81.

*Estimated Total Annual Burden on Respondents:* 168 hours.

#### Agency Information Collection Activities; Submission to the Office of Management and Budget (OMB) for Review and Approval; Comment Request; Direct Investment Surveys: BE-11, Annual Survey of U.S. Direct Investment Abroad

The Department of Commerce will submit the following information collection request to the Office of Management and Budget (OMB) for review and clearance in accordance with the Paperwork Reduction Act of 1995, on or after the date of publication of this notice. We invite the general public and other Federal agencies to comment on proposed, and continuing information collections, which helps us assess the impact of our information collection requirements and minimize the public's reporting burden. Public comments were previously requested via the **Federal Register** on 06/16/2025 during a 60-day comment period. This notice allows for an additional 30 days for public comments.

*Agency:* Bureau of Economic Analysis (BEA), Department of Commerce.

*Title:* Annual Survey of U.S. Direct Investment Abroad.

*OMB Control Number:* 0608-0053.

*Form Number:* BE-11.

*Type of Request:* Reinstatement with change of a previously approved collection.

*Number of Respondents:* 3,000 respondents (U.S. parents). A complete response includes a BE-11 A form for the U.S. parent's domestic operation and one or more BE-11 B or D forms for its foreign affiliates that meet the BE-11 survey requirements. BEA estimates that U.S. parents will submit 3,000 A forms, 22,000 B forms, 130 D forms, and 500 Claim for Exemption forms.

*Average Hours per Response:* 95.2 hours per respondent (285,630 hours/3,000 U.S. parents) is the average but may vary considerably among respondents because of differences in company structure, complexity, and the number of foreign affiliates each U.S. parent must report.

*Burden Hours:* 285,630 hours. Total annual burden is calculated by multiplying the estimated number of submissions of each form by the average hourly burden per form, which is 7 hours for the A form, 12 hours for the B form, 1 hour for the D form, and 1 hour for the Claim for Exemption form.

*Needs and Uses:* The Annual Survey of U.S. Direct Investment Abroad (BE-11) obtains sample data on the financial

structure and operations of U.S. parents and their foreign affiliates. The data are needed to provide reliable, useful, and timely measures of U.S. direct investment abroad to assess its impact on the U.S. and foreign economies. The sample data are used to derive universe estimates in nonbenchmark years from similar data reported in the BE-10, Benchmark Survey of U.S. Direct Investment Abroad, which is conducted every five years. The data collected include balance sheets; income statements; property, plant, and equipment; employment and employee compensation; merchandise trade; sales of goods and services; taxes; and research and development activity.

*Affected Public:* Businesses or other for-profit organizations.

*Frequency:* Annual.

*Respondent's Obligation:* Mandatory.

*Legal Authority:* International Investment and Trade in Services Survey Act (P. L. 94-472, 22 U.S.C. 3101-3108, as amended).
