

*Changes in the estimates:* There is a decrease of 54 hours in the total estimated respondent burden compared with the ICR currently approved by OMB. The previous ICR reflected those burdens and costs associated with the initial activities for subject facilities due to the 2020 amendments. This included time to familiarize with CEDRI for electronic reporting and revision of record systems due to the revisions for periods of startup, shutdown, and malfunction. There is also a decrease in the Capital O&M compared to the previously approved ICR. Most of the Capital O&M included with the previous ICR is associated with capital and startup costs. This ICR, by in large, reflects the on-going burden and costs for existing facilities following rulemaking activities.

**SUMMARY:** The Environmental Protection Agency (EPA) has submitted an information collection request (ICR), NESHAP for Site Remediation (EPA ICR Number 2062.11, OMB Control Number 2060-0534) to the Office of Management and Budget (OMB) for review and approval in accordance with the Paperwork Reduction Act. This is a proposed extension of the ICR, which is currently approved through February 28, 2025. Public comments were previously requested via the **Federal Register** on May 18, 2023 during a 60-day comment period. This notice allows for an additional 30 days for public comments.

**Abstract:** The NESHAP for Site Remediation was proposed on July 30, 2002, promulgated on October 8, 2003, and most recently amended on July 10, 2020 and December 22, 2022. These regulations apply to site remediation activities that clean up materials containing organic hazardous air pollutants (HAP), where the site remediation is co-located at any facility

with one or more stationary source that emit HAP, and where the facility is a major source of HAP. Major sources of HAP are sources that emit any single HAP at a rate of 10 tons or more per year or any combination of HAP at a rate of 25 tons or more per year. Site remediation activities may potentially occur at any facility where materials containing organic HAP currently are or have been stored, processed, treated, or otherwise managed at the facility. The types of businesses most likely to be subject to this rule include, but are not limited to, organic liquid storage terminals, petroleum refineries, chemical manufacturing facilities, and manufacturing facilities using organic materials. New facilities include those that commenced construction, modification, or reconstruction after the date of proposal. This information is being collected to assure compliance with 40 CFR part 63, subpart GGGGG. In general, all NESHAP standards require initial notifications, performance tests, and periodic reports by the owners/operators of the affected facilities. They are also required to maintain records of the occurrence and duration of any startup, shutdown, or malfunction in the operation of an affected facility, or any period during which the monitoring system is inoperative. These notifications, reports, and records are essential in determining compliance, and are required of all affected facilities subject to NESHAP.

*Form Numbers:* 5900-706.

*Respondents/affected entities:* Facilities conducting site remediation activities.

*Respondent's obligation to respond:* Mandatory (40 CFR part 63, subpart GGGGG).

*Estimated number of respondents:* 104 (total).

*Frequency of response:* Initially and semiannually.

*Total estimated burden:* 47,100 hours (per year). Burden is defined at 5 CFR 1320.03(b).

*Total estimated cost:* \$5,670,000 (per year), which includes \$256,000 annualized capital or operation & maintenance costs.

*Changes in the Estimates:* There is an increase in the total estimated respondent burden compared with the ICR currently approved by OMB. This increase is due to an increase in the number of respondents. A December 2022 rulemaking amended this subpart by removing an exemption from the applicability provisions for site remediation activities performed under the authority of the Comprehensive Environmental Response and Compensation Liability Act (CERCLA)

and for site remediation activities performed under a Resource Conservation and Recovery Act (RCRA) corrective action or other required RCRA order. This resulted in an increase in the number of respondents and estimated burden. This ICR further adjusts the burden based on the assumption that the initial requirements for new sources have already been met. There is a decrease in capital costs based on the assumption that initial capital costs have already been incurred by facilities that became subject to the rule in December 2022. There is an increase in O&M costs due to the increased number of existing facilities that conduct O&M activities.

**Abstract:** The scope of this ICR is the electronic reporting components of the Cross-Media Electronic Reporting Rule (CROMERR), which is designed to: (i) allow EPA to comply with the Government Paperwork Elimination Act of 1998; (ii) provide a uniform, technology-neutral framework for electronic reporting across all EPA programs; (iii) allow EPA programs to offer electronic reporting as they become ready for CROMERR; and (iv)

provide states with a streamlined process—together with a uniform set of standards—for approval of their electronic reporting provisions for all their EPA-authorized programs. Responses to the collection of information are voluntary. In order to accommodate CBI, the information collected must be in accordance with the confidentiality regulations set forth in 40 CFR part 2, subpart B. Additionally, EPA will ensure that the information collection procedures comply with the Privacy Act of 1974 and the OMB Circular 108.

**Form Numbers:** None.

**Respondents/affected entities:** Entities that report electronically to EPA and state or local government authorized programs; and state and local government authorized programs implementing electronic reporting.

**Respondent's obligation to respond:** Required to obtain or retain a benefit (CROMERR was established to ensure compliance with the Government Paperwork Elimination Act (GPEA)).

**Estimated number of respondents:** 77,716 (total).

**Frequency of response:** On Occasion.

**Total estimated burden:** 65,319 hours (per year). Burden is defined at 5 CFR 1320.03(b).

**Total estimated cost:** \$4,614,717 (per year), which includes \$1,283,547 annualized capital or operation & maintenance costs.

**Changes in the estimates:** There is a decrease of 81,985 hours in the total estimated respondent burden compared with the ICR currently approved by OMB. The decrease in respondent burden can be attributed primarily to two reasons. First, a decrease in the number of direct reporters that will register with EPA's electronic document receiving system. Second, a decrease in the number of indirect reporters that will comply with paper subscriber agreement and ESA provisions associated with systems with SCS solutions. Both estimates are based on data from CDX. Thus, the Agency believes that the revised estimates accurately reflect the number of respondents.

The overall change in respondent burden is considered an "adjustment," because it results from changes in the respondent universe and hourly burden estimates used in the development of the ICR.
