The proposed project would consist of the following new facilities: (1) a 15,340-foot-long, 75-foot-high rolled concrete dam that would impound a 176-acre upper reservoir with a storage capacity of 11,300 acre-feet at a water surface elevation of 7,560 feet above mean sea level (msl); (2) a 3,793-footlong, 80-foot-high rockfill/concrete dam that would impound a 147-acre lower reservoir with a storage capacity of 11,300 acre-feet at a water surface elevation of 4.300 feet msl: (3) a 6.800foot-long, 42-foot-diameter concrete penstock from the upper reservoir to eight 330-foot-long, 15-foot-diameter turbine penstocks; (4) a 1,600-foot-long, 150-foot-wide, 60-foot-high underground concrete powerhouse containing eight 250–MW pump-turbine generators; (5) a 2,750-foot-long, 42-footdiameter concrete tailrace; (6) a 1-milelong steel well water supply pipeline connecting to existing wells for initial fill water; (7) an 11.7-mile-long, 345kilovolt transmission line; and (8) appurtenant facilities. Additionally, Gravity Storage proposes to install Solar Power plants on the surface of the upper and lower reservoirs to minimize evaporation due to the arid desert climate. The proposed project would have an estimated annual generation of 8,000 gigawatt-hours.
