*Abstract:* This request is for an extension of the application booklet for the Strengthening Institutions Program (SIP), Assistance Listing Numbers (ALN) # 84.031A and 84.031F. SIP provides grants to eligible institutions of higher education (IHEs) to improve their academic programs, institutional management, and fiscal stability to increase their self-sufficiency and strengthen their capacity. Funding is targeted to institutions that enroll a large proportion of financially disadvantaged students and have low per-student expenditures. Section 311(b) and Section 391(a)(1) of Title III, Part A of the Higher Education Act of 1965, as amended (HEA), 20 US Code Section 1057 and the governing regulations (34 CFR 607.1–607.31) require collection of the information identified in the application package prior to any new awards being made.

This collection is being submitted under the Streamlined Clearance Process for Discretionary Grant Information Collections (1894–0001). Therefore, the 30-day public comment period notice will be the only public comment notice published for this information collection.

#### Eagle Creek Reusens Hydro, LLC; Notice of Intent To Prepare an Environmental Assessment

On February 28, 2022, Eagle Creek Reusens Hydro, LLC filed a relicense application for the 12.5-megawatt Reusens Hydroelectric Project No. 2376 (Reusens Project or project). The project is located on the James River in Bedford and Amherst Counties, Virginia.

In accordance with the Commission's regulations, on May 13, 2025, Commission staff issued a notice that the Reusens Project was ready for environmental analysis (REA Notice). Based on the information in the record, including comments filed on the REA Notice, staff does not anticipate that licensing the Reusens Project would constitute a major federal action significantly affecting the quality of the human environment. Therefore, staff intends to prepare an Environmental Assessment (EA) on the application to relicense the Reusens Project.<sup>1</sup>

The EA will be issued and circulated for review by all interested parties. All comments filed on the EA will be analyzed by staff and considered in the Commission's final licensing decision.

The Commission's Office of Public Participation (OPP) supports meaningful public engagement and participation in Commission proceedings. OPP can help members of the public, including landowners, community organizations, Tribal members, and others, access publicly available information and navigate Commission processes. For public inquiries and assistance with making filings such as interventions,
