Description: The CRA requires the Office of the Comptroller of the Currency, the Board of Governors of the Federal Reserve System, and the Federal **Deposit Insurance Corporation** (agencies) to assess the record of regulated financial institutions (institutions) in helping to meet the credit needs of their entire communities, including low- and moderate-income neighborhoods, consistent with safe and sound operations. The CRA further requires the agencies to take this record into account in evaluating applications for mergers, branches, and certain other corporate activities.2 The CRA statute requires the agencies to issue regulations to carry out its purposes.3

The agencies use the data collected under the CRA regulations to fulfill their statutory obligations, including the assessment of each institution's record
