#### Information Collection Request to Office of Management and Budget; OMB Control Number: 1625-0121

**AGENCY:** Coast Guard, DHS.

**ACTION:** Sixty-Day notice requesting comments.

**SUMMARY:** In compliance with the Paperwork Reduction Act of 1995, the U.S. Coast Guard intends to submit an Information Collection Request (ICR) to the Office of Management and Budget (OMB), Office of Information and Regulatory Affairs (OIRA), requesting an extension of its approval for the following collection of information: 1625-0121, United States Coast Guard Academy Introduction Mission Program Application and Supplemental Forms; reinstatement with change. Since the last application of February 27, 2018, changes include updated submission dates and additional medical clearance questions for the application to ensure applicants are medically safe to train. The ICR describes the information we seek to collect from the public. Before submitting this ICR to OIRA, the Coast Guard is inviting comments as described below.
