SUPPLEMENTARY INFORMATION: We, the U.S. Fish and Wildlife Service (Service), are initiating 5-year status reviews under the Endangered Species Act of 1973, as amended (ESA; 16 U.S.C. 1531 et seq.) for the short-tailed albatross (Phoebastria albatrus) and the wood bison (Bison bison athabascae). A 5-vear status review is based on the best scientific and commercial data available at the time of the review. Therefore, we are requesting submission of any such information that has become available since the last review for these species in 2020, particularly information on the status, threats, and recovery of the species.

Why do we conduct 5-year reviews?

Under the ESA, we maintain Lists of Endangered and Threatened Wildlife and Plants (which we collectively refer to as the List) in title 50 of the Code of Federal Regulations (CFR) at 50 CFR 17.11 (for wildlife) and 50 CFR 17.12 (for plants). Section 4(c)(2)(A) of the ESA (16 U.S.C. 1533(c)(2)(A)) requires us to review each listed species' status at least once every 5 years. Our regulation at 50 CFR 424.21 requires that we publish a notice in the Federal **Register** announcing that a species is under active review. For additional information about 5-year reviews, refer to our fact sheet at https://www.fws.gov/ project/five-year-status-reviews.

What information do we consider in our reviews?

A 5-year status review considers all new information available at the time of the review. In conducting these reviews, we consider the best scientific and commercial data that have become available since the current listing determination or most recent status review of each species, such as:

- A. Species biology, including but not limited to population trends, distribution, abundance, demographics, and genetics;
- B. Habitat conditions, including but not limited to amount, distribution, and suitability;
- C. Conservation measures that have been implemented that benefit the species;
- D. Threat status and trends in relation to the five listing factors (as defined in section 4(a)(1) of the ESA (16 U.S.C. 1533(a)(1)); and
- E. Other new information, data, or corrections, including but not limited to taxonomic or nomenclatural changes, identification of erroneous information contained in the List, and improved analytical methods.

Any new information will be considered during the 5-year review and will also be useful in evaluating the ongoing recovery programs for the species.
