

Governing Board meeting will convene in open session from 9:05 a.m. to 10:45 a.m., in closed session from 10:45 a.m. to 5 p.m., and in open session from 5–6 p.m. From 9:05 a.m. to 9:15 a.m., Beverly Perdue, Chair of the Governing Board, will welcome members, make remarks, review and approve the May 15–16, 2025, quarterly Governing Board meeting agenda, and approve the minutes from the March 6, 2025, Governing Board meeting.

From 9:15 a.m. to 9:30 a.m., Lesley Muldoon, Governing Board Executive Director, will provide updates on the Board's work and priorities. Representatives from the Council of Chief State School Officers (CCSSO) and the Council of the Great City Schools will discuss the work of the task forces the Board leads jointly with them—State Policy Task Force and Trial Urban District Assessment (TUDA) Task Force respectively—from 9:30 a.m. to 10:30 a.m. Following a fifteen-minute transitional break, the Board will meet in closed session from 10:45 a.m. to 12 p.m. to receive an update on the NAEP Budget and Contracting from IES Director, Matt Soldner, and NCES Director for Strategic Partnerships, Gina Broxterman. The Board will continue in closed session from 12:15 p.m. to 3:30 p.m., to discuss the NAEP Budget and Contracting. From 3:45 p.m. to 5 p.m. the Board will receive an embargoed briefing on the 2024 NAEP Science Results. These sessions must be closed because they will include information on the budget and the federal acquisition process and embargoed assessment results, both of which cannot be released to the public at this time. Public disclosure of this confidential information would significantly impede implementation of the NAEP assessment program if conducted in open session. Such matters are protected by exemption 9(B) of the Government Sunshine Act, 5 U.S.C. 552b.

Following a short transitional break, the Board will convene in open session from 5:15 p.m. to 5:45 p.m. to discuss topics of interest raised by members. From 5:45 p.m. to 6 p.m., the Board will discuss and take action on the release plan for 2024 NAEP Science. The Thursday, May 15, 2024, session of the Governing Board meeting will adjourn at 6 p.m.

**Idaho Power Company; Notice of Revised Procedural Schedule for the Supplemental Environmental Impact Statement for the Hells Canyon Project**

On July 29, 2003, Idaho Power Company (Idaho Power) filed an application for a new license to continue to operate and maintain the Hells Canyon Project No. 1971.<sup>1</sup> On August 31, 2007, the Commission issued a final Environmental Impact Statement (EIS) for the Hells Canyon Project. On December 30, 2019, Idaho Power filed an Offer of Settlement (settlement) with the Commission for the Hells Canyon Project.<sup>2</sup> The settlement, which was executed on April 22, 2019, includes, among other items, spring Chinook salmon and summer steelhead fish passage measures. In addition, the Oregon and Idaho Departments of Environmental Quality each issued a water quality certification under section 401 of the Clean Water Act for the Hells Canyon Project on May 24, 2019.

On July 8, 2020, Idaho Power supplemented the final license application for the project with additional information on its proposal, including an analysis of the new and revised fish-related protection, mitigation, and enhancement measures proposed under the settlement, and updated information on environmental

resources. Additionally, Idaho Power filed on October 14, 2020, draft biological assessments for species managed by the U.S. Fish and Wildlife Service and the National Marine Fisheries Service, which included an analysis of the effects of the new and revised measures on fish and wildlife listed under the Endangered Species Act (ESA).<sup>3</sup>

On June 13, 2022, Commission staff issued a notice of intent to prepare a draft and final EIS to assess the new and revised fish-related protection, mitigation, and enhancement measures proposed under the settlement, the Oregon and Idaho water quality certifications, and the draft biological assessments. The notice of intent included a schedule for preparing a draft and final supplemental EIS.

By notices issued October 12, 2023 and May 17, 2024, Commission staff revised the procedural schedule for issuing the draft and final supplemental EIS. The revised date for issuing the draft supplemental EIS was to be July 2024. On October 23, 2024, Idaho Power filed a settlement with the Commission on behalf of itself and the U.S. Forest Service (Forest Service), which was executed on October 22, 2024. The settlement resolves, between the signatories, the appropriate terms and conditions pursuant to section 4(e) of the Federal Power Act to be incorporated into any new license, if issued for the project, for the protection and utilization of federal lands administered by the Forest Service within and adjacent to the project boundary.<sup>4</sup> Additionally, Idaho Power is currently revising several draft biological assessments, which are tentatively scheduled to be filed with the Commission in June 2025.

By this notice, Commission staff is updating the procedural schedule for completing the draft and final supplemental EIS to provide sufficient time for staff to analyze the October 23, 2024, settlement and any revised draft biological assessments in the draft supplemental EIS. Further revisions to the schedule may be made as appropriate.

**Golden Pass LNG Terminal LLC; Notice Of Application and Establishing Intervention Deadline**

Take notice that on April 11, 2025, Golden Pass LNG Terminal LLC (Golden Pass LNG), 811 Louisiana Street, Suite 1500, Houston, Texas 77002, filed an application under section 3 of the Natural Gas Act (NGA) and Part 153 of the Commission’s regulations requesting authorization to amend its existing authorization for the Export Terminal Project granted by the Commission on December 21, 2016.<sup>1</sup> Specifically, Golden Pass LNG requests approval to construct an approximately 1.1-miles of 42-inch-diameter natural gas supply lateral pipeline and associated receipt manifold at its existing LNG terminal located in Sabine Pass, Texas (Supply Lateral Project or Project). The proposed lateral will connect with the Trident Intrastate Pipeline LLC facilities at the receipt manifold. Golden Pass LNG also requests authority to construct a receipt point tie-in and meter that would connect to a new interstate header being developed by Kinder Morgan Louisiana Pipeline LLC (KMLP Receipt Point Project).<sup>2</sup> Together, the projects would provide supply security and flexibility to the LNG terminal, all as more fully set forth in the application which is on file with the Commission and open for public inspection.

In addition to publishing the full text of this document in the **Federal Register**, the Commission provides all interested persons an opportunity to
