Background.—On July 10, 2014, the Department of Commerce ("Commerce") suspended an antidumping duty investigation on imports of oil country tubular goods from Ukraine (79 FR 41959, July 18, 2014). On September 10, 2014, Commerce issued countervailing duty orders on imports of oil country tubular goods from India and Turkey (79 FR 53688) and antidumping duty orders on imports of oil country tubular goods from India, South Korea, Turkey, and Vietnam (79 FR 53691). On July 10, 2019, Commerce terminated the suspension agreement and issued an antidumping duty order on imports of oil country tubular goods from Ukraine (84 FR 33918, July 16, 2019). Following the five-year reviews by Commerce and the Commission, effective August 12, 2020, Commerce issued a continuation of the countervailing duty orders on imports of oil country tubular goods from India and Turkey and the antidumping duty orders on imports of oil country tubular goods from India, South Korea, Turkey, Ukraine, and Vietnam (85 FR 48665). The Commission is now conducting second reviews pursuant to section 751(c) of the Act, as amended (19 U.S.C. 1675(c)), to determine whether revocation of the orders would be likely to lead to continuation or recurrence of material injury to the domestic industry within a reasonably foreseeable time. Provisions concerning the conduct of this proceeding may be found in the Commission's Rules of Practice and Procedure at 19 CFR part 201, subparts A and B, and 19 CFR part 207, subparts A and F. The Commission will assess the adequacy of interested party responses to this notice of institution to determine whether to conduct full or expedited reviews. - (1) Subject Merchandise is the class or kind of merchandise that is within the scope of the five-year reviews, as defined by Commerce.
- (2) The Subject Countries in these reviews are India, South Korea, Turkey, Ukraine, and Vietnam.
- (3) The Domestic Like Product is the domestically produced product or products which are like, or in the absence of like, most similar in characteristics and uses with, the Subject Merchandise. In its original determinations and full five-year review determinations, the Commission defined the Domestic Like Product as all oil country tubular goods, coextensive with Commerce's scope.

(4) The Domestic Industry is the U.S. producers as a whole of the *Domestic* Like Product, or those producers whose collective output of the Domestic Like Product constitutes a major proportion of the total domestic production of the product. In its original determinations and full five-year review determinations, the Commission defined the Domestic Industry to include all U.S. producers of oil country tubular goods, including both mills that produce oil country tubular goods and processors that engage in heat treatment.

(5) An *Importer* is any person or firm engaged, either directly or through a parent company or subsidiary, in importing the Subject Merchandise into the United States from a foreign manufacturer or through its selling agent.
