At the time of retirement, an employee or Member in good health may elect an insurable interest survivor annuity benefit on behalf of an eligible beneficiary. OPM Form 1530 is used to collect the information necessary to determine whether the employee or

Member is in good health so that OPM can determine whether the applicant is eligible to elect an insurable interest survivor annuity benefit.
