Abstract: The purpose of Client Assistance Program (CAP) is to advise and inform applicants and individuals eligible for services and benefits available under the Rehabilitation Act of 1973 (Rehabilitation Act), as amended by the Workforce Innovation and Opportunity Act (WIOA), and title I of the Americans with Disabilities Act of 1990 (ADA), including students with disabilities under section 113 and individuals with disabilities employed at subminimum wage under section 511 of the Rehabilitation Act. In addition, applicants and eligible individuals may be provided advocacy and representation to ensure their rights in their relationship with projects, programs, and services to protect their rights provided under the Rehabilitation Act. In addition to providing assistance and advocacy under the Rehabilitation Act, a CAP agency may provide information on the assistance and benefits on title I of the ADA, especially

those who have traditionally been unserved or underserved by the vocational rehabilitation program, with respect to services that are directly related to facilitating the employment for applicants or eligible individuals.

Notice of Request Under Blanket Authorization and Establishing Intervention and Protest Deadline; WBI Energy Transmission, Inc.

Take notice that on March 31, 2025, WBI Energy Transmission, Inc. (WBI Energy), 1250 West Century Avenue,

Bismarck, North Dakota 58503, filed in the above referenced docket, a prior notice request pursuant to sections 157.205 and 157.216(b) of the Commission’s regulations under the Natural Gas Act (NGA), and WBI Energy’s blanket certificate issued in Docket No. CP82–487–000, for authorization to abandon six natural gas storage wells, approximately 4.07 miles of associated three-inch, four-inch and twelve-inch-diameter natural gas storage pipeline and appurtenant facilities. All of the above facilities are located in WBI Energy’s Baker Storage Field in Fallon County, Montana (2025 Baker Storage Well Abandonment Project). WBI Energy concludes that the abandonment will limit integrity risk in alignment with the guidance of the Pipeline and Hazardous Materials Safety Administration Storage Final Rule. The estimated cost for the project is \$7,600,000, all as more fully set forth in the request which is on file with the Commission and open to public inspection.
