The Bryson Project consists of a multiple arch dam with multiple spillway and overflow sections, a 38-acre reservoir, and two vertical Francis-type generating units located on the Oconaluftee River in Swain County, North Carolina. The project does not occupy any Federal lands.

The final EA contains Commission staff's analysis of the potential environmental effects of the proposed surrender, alternatives to the proposed action, and concludes that the proposed surrender, with appropriate environmental protective measures,

would not constitute a major Federal action that would significantly affect the quality of the human environment.
