**Idaho Power Company; Notice of Revised Procedural Schedule for the Supplemental Environmental Impact Statement for the Hells Canyon Project**

On July 29, 2003, Idaho Power Company (Idaho Power) filed an application for a new license to continue to operate and maintain the Hells Canyon Project No. 1971.<sup>1</sup> On August 31, 2007, the Commission issued a final Environmental Impact Statement (EIS) for the Hells Canyon Project. On December 30, 2019, Idaho Power filed an Offer of Settlement (settlement) with the Commission for the Hells Canyon Project.<sup>2</sup> The settlement, which was executed on April 22, 2019, includes, among other items, spring Chinook salmon and summer steelhead fish passage measures. In addition, the Oregon and Idaho Departments of Environmental Quality each issued a water quality certification under section 401 of the Clean Water Act for the Hells Canyon Project on May 24, 2019.

On July 8, 2020, Idaho Power supplemented the final license application for the project with additional information on its proposal, including an analysis of the new and revised fish-related protection, mitigation, and enhancement measures proposed under the settlement, and updated information on environmental

resources. Additionally, Idaho Power filed on October 14, 2020, draft biological assessments for species managed by the U.S. Fish and Wildlife Service and the National Marine Fisheries Service, which included an analysis of the effects of the new and revised measures on fish and wildlife listed under the Endangered Species Act (ESA).<sup>3</sup>

On June 13, 2022, Commission staff issued a notice of intent to prepare a draft and final EIS to assess the new and revised fish-related protection, mitigation, and enhancement measures proposed under the settlement, the Oregon and Idaho water quality certifications, and the draft biological assessments. The notice of intent included a schedule for preparing a draft and final supplemental EIS.

By notices issued October 12, 2023 and May 17, 2024, Commission staff revised the procedural schedule for issuing the draft and final supplemental EIS. The revised date for issuing the draft supplemental EIS was to be July 2024. On October 23, 2024, Idaho Power filed a settlement with the Commission on behalf of itself and the U.S. Forest Service (Forest Service), which was executed on October 22, 2024. The settlement resolves, between the signatories, the appropriate terms and conditions pursuant to section 4(e) of the Federal Power Act to be incorporated into any new license, if issued for the project, for the protection and utilization of federal lands administered by the Forest Service within and adjacent to the project boundary.<sup>4</sup> Additionally, Idaho Power is currently revising several draft biological assessments, which are tentatively scheduled to be filed with the Commission in June 2025.

By this notice, Commission staff is updating the procedural schedule for completing the draft and final supplemental EIS to provide sufficient time for staff to analyze the October 23, 2024, settlement and any revised draft biological assessments in the draft supplemental EIS. Further revisions to the schedule may be made as appropriate.

**Golden Pass LNG Terminal LLC; Notice Of Application and Establishing Intervention Deadline**

Take notice that on April 11, 2025, Golden Pass LNG Terminal LLC (Golden Pass LNG), 811 Louisiana Street, Suite 1500, Houston, Texas 77002, filed an application under section 3 of the Natural Gas Act (NGA) and Part 153 of the Commission’s regulations requesting authorization to amend its existing authorization for the Export Terminal Project granted by the Commission on December 21, 2016.<sup>1</sup> Specifically, Golden Pass LNG requests approval to construct an approximately 1.1-miles of 42-inch-diameter natural gas supply lateral pipeline and associated receipt manifold at its existing LNG terminal located in Sabine Pass, Texas (Supply Lateral Project or Project). The proposed lateral will connect with the Trident Intrastate Pipeline LLC facilities at the receipt manifold. Golden Pass LNG also requests authority to construct a receipt point tie-in and meter that would connect to a new interstate header being developed by Kinder Morgan Louisiana Pipeline LLC (KMLP Receipt Point Project).<sup>2</sup> Together, the projects would provide supply security and flexibility to the LNG terminal, all as more fully set forth in the application which is on file with the Commission and open for public inspection.

In addition to publishing the full text of this document in the **Federal Register**, the Commission provides all interested persons an opportunity to

Pursuant to section 157.9 of the Commission's Rules of Practice and Procedure,<sup>3</sup> within 90 days of this Notice the Commission staff will either: complete its environmental review and place it into the Commission's public record (eLibrary) for this proceeding; or issue a Notice of Schedule for Environmental Review. If a Notice of Schedule for Environmental Review is issued, it will indicate, among other milestones, the anticipated date for the Commission staff's issuance of the final environmental impact statement (FEIS) or environmental assessment (EA) for this proposal. The filing of an EA in the Commission's public record for this proceeding or the issuance of a Notice of Schedule for Environmental Review will serve to notify federal and state agencies of the timing for the completion of all necessary reviews, and the subsequent need to complete all federal authorizations within 90 days of the date of issuance of the Commission staff's FEIS or EA.

### Water Quality Certification

Golden Pass LNG stated that a water quality certificate under section 401 of the Clean Water Act is required for the project from Railroad Commission of Texas (RRC). When available, Golden Pass LNG should submit to the Commission a copy of the request for certification for the Commission

authorization, including the date the request was submitted to the certifying agency, and either (1) a copy of the certifying agency's decision or (2) evidence of waiver of water quality certification.

### Public Participation

There are three ways to become involved in the Commission's review of this project: you can file comments on the project, you can protest the filing, and you can file a motion to intervene in the proceeding. There is no fee or cost for filing comments or intervening. The deadline for filing a motion to intervene is 5:00 p.m. Eastern Time on May 15, 2025. How to file protests, motions to intervene, and comments is explained below.

### Comments

Any person wishing to comment on the project may do so. Comments may include statements of support or objections, to the project as a whole or specific aspects of the project. The more specific your comments, the more useful they will be.

### Protests

Pursuant to sections 157.10(a)(4)<sup>4</sup> and 385.211<sup>5</sup> of the Commission's regulations under the NGA, any person<sup>6</sup> may file a protest to the application. Protests must comply with the requirements specified in section 385.2001<sup>7</sup> of the Commission's regulations. A protest may also serve as a motion to intervene so long as the protestor states it also seeks to be an intervenor.

To ensure that your comments or protests are timely and properly recorded, please submit your comments on or before May 15, 2025.

There are three methods you can use to submit your comments or protests to the Commission. In all instances, please

reference the Project docket number CP25-205-000 in your submission.

Persons who comment on the environmental review of this project will be placed on the Commission's environmental mailing list, and will receive notification when the environmental documents (EA or EIS) are issued for this project and will be notified of meetings associated with the Commission's environmental review process.

The Commission considers all comments received about the project in determining the appropriate action to be taken. *However, the filing of a comment alone will not serve to make the filer a party to the proceeding.* To become a party, you must intervene in the proceeding. For instructions on how to intervene, see below.

### Interventions

Any person, which includes individuals, organizations, businesses,

municipalities, and other entities,<sup>8</sup> has the option to file a motion to intervene in this proceeding. Only intervenors have the right to request rehearing of Commission orders issued in this proceeding and to subsequently challenge the Commission's orders in the U.S. Circuit Courts of Appeal.

To intervene, you must submit a motion to intervene to the Commission in accordance with Rule 214 of the Commission's Rules of Practice and Procedure<sup>9</sup> and the regulations under the NGA<sup>10</sup> by the intervention deadline for the project, which is May 15, 2025. As described further in Rule 214, your motion to intervene must state, to the extent known, your position regarding the proceeding, as well as your interest in the proceeding. For an individual, this could include your status as a landowner, ratepayer, resident of an impacted community, or recreationist. You do not need to have property directly impacted by the project in order to intervene. All timely, unopposed<sup>11</sup> motions to intervene are automatically granted by operation of Rule 214(c)(1).<sup>12</sup> Motions to intervene that are filed after the intervention deadline are untimely and may be denied. Any late-filed motion to intervene must show good cause for being late and must explain why the time limitation should be waived and provide justification by reference to factors set forth in Rule 214(d) of the Commission's Rules and Regulations.<sup>13</sup> A person obtaining party status will be placed on the service list maintained by the Secretary of the Commission and will receive copies (paper or electronic) of all documents filed by the applicant and by all other parties.
