Qualifying Facility Rates and Requirements; Implementation Issues Under the Public Utility Regulatory Policies Act of 1978; Notice of Revised Procedural Schedule for the Environmental Assessment for Qualifying Facility Rates and Requirements Implementation Issues Under the Public Utility Regulatory Policies Act of 1978

On July 16, 2020, the Federal Energy Regulatory Commission (Commission) issued Order No. 872,¹ approving certain revisions to its regulations implementing sections 201 and 210 of the Public Utility Regulatory Policies Act of 1978 (PURPA).² On September 5, 2023, the U.S. Court of Appeals for the Ninth Circuit (Ninth Circuit) remanded Order No. 872, without vacatur, based on its finding that, pursuant to the National Environmental Policy Act (NEPA),³ the Commission must prepare an environmental assessment (EA) analyzing the potential impacts of the rule on climate change and air quality.⁴

On September 24, 2024, Commission staff issued a notice of intent to prepare an EA, which included an anticipated schedule for issuing the EA and a comment period.

By this notice, Commission staff is updating the procedural schedule⁵ and setting forth a revised schedule for completion of the EA. The revised schedule is shown below.

Schedule for Environmental Review

Issuance of EA—June 30, 2025

End of Public Comment Period—July 30, 2025

If a schedule change becomes necessary, additional notice will be provided so that the relevant agencies are kept informed of the progress.

City of St. Cloud, Minnesota; Notice of Authorization for Continued Project Operation

The license for the St. Cloud Hydroelectric Project No. 4108 was issued for a period ending November 30, 2024.

Section 15(a)(1) of the FPA, 16 U.S.C. 808(a)(1), requires the Commission, at the expiration of a license term, to issue from year-to-year an annual license to the then licensee(s) under the terms and conditions of the prior license until a new license is issued, or the project is otherwise disposed of as provided in section 15 or any other applicable section of the FPA. If the project's prior license waived the applicability of section 15 of the FPA, then, based on section 9(b) of the Administrative Procedure Act, 5 U.S.C. 558(c), and as set forth at 18 CFR 16.21(a), if the licensee of such project has filed an application for a subsequent license, the licensee may continue to operate the project in accordance with the terms and conditions of the license after the minor or minor part license expires, until the Commission acts on its application. If the licensee of such a project has not filed an application for a subsequent license, then it may be required, pursuant to 18 CFR 16.21(b), to continue project operations until the Commission issues someone else a license for the project or otherwise orders disposition of the project.

If the project is subject to section 15 of the FPA, notice is hereby given that an annual license for Project No. 4108 is issued to the City of St. Cloud for a period effective December 1, 2024, through November 30, 2025, or until the issuance of a new license for the project or other disposition under the FPA, whichever comes first.

If issuance of a new license (or other disposition) does not take place on or before November 30, 2025, notice is hereby given that, pursuant to 18 CFR 16.18(c), an annual license under section 15(a)(1) of the FPA is renewed

automatically without further order or notice by the Commission, unless the Commission orders otherwise.

If the project is not subject to section 15 of the FPA, notice is hereby given that the City of St. Cloud is authorized to continue operation of the St. Cloud Hydroelectric Project under the terms and conditions of the prior license until the issuance of a subsequent license for the project or other disposition under the FPA, whichever comes first.

Black Bayou Gas Storage, LLC; Notice of Revised Schedule for Environmental Review of the Black Bayou Gas Storage Project

This notice identifies the Federal Energy Regulatory Commission staff's revised schedule for the completion of the environmental assessment (EA) for Black Bayou Gas Storage, LLC's Black Bayou Gas Storage Project.¹ The first notice of schedule, issued on October 2, 2024, identified February 14, 2025, as the EA issuance date. However, additional time is required for Black Bayou Gas Storage, LLC to file complete responses to staff's environmental information requests, and for staff to review those responses. As a result, staff has revised the schedule for issuance of the EA based on an expected receipt of all outstanding information by December 31, 2024.
