# Executive Order 13175, Consultation and Coordination With Indian Tribal Governments

Executive Order 13175 requires federal agencies to consult and coordinate with tribes on a governmentto-government basis on policies that have tribal implications. The Forest Service consulted and provided an overview of the CWDG program to Tribal entities in coordination with the FS Office of Tribal Relations. In addition, a tribal liaison was a member of the stakeholder group developing the program. An informational webinar specific to Tribes will occur during the first two weeks of August 2022 and will be recorded for future viewing. The webinar's date, time, and registration information will be made available on the following web page: www.fs.usda.gov/managing-land/fire/ grants. Cost-sharing requirements are mandated in the Infrastructure Investment and Jobs Act. Communities meeting the definition of underserved per Executive Order 13985 are eligible to request a waiver of match requirements.

# **Non-Discrimination Statement**
