

belongings removed from CA-SAC-47, CA-SAC-92, CA-SAC-101, CA-SAC-132, CA-SAC-207, Ledbedder Mound, Franklin, unknown burial areas, and the Sacramento River. The unassociated funerary belongings include beads, cups, charmstones, projectile points, stone tools, lithics, sinkers, worked bone, ornaments, pendants, faunal remains, pipes, and ground stone.

Of the cultural items requested, 45 lots are objects of cultural patrimony removed from CA-SAC-137, CA-SAC-142, CA-SAC-143, Linda Creek, Loupe Ranch, and Sylvan. The objects of cultural patrimony include ground stone, mullers, hammerstones, baked clay, awls, lithics, scrapers, and faunal remains.

Collections and collection spaces at the Phoebe A Hearst Museum of Anthropology were treated with substances for preservation and pest control, some potentially hazardous. No records have been found to date at the Museum to indicate whether or not chemicals or natural substances were used prior to 1960.

#### Determinations

The University of California, Berkeley has determined that:

- The 123 unassociated funerary objects described in this notice are reasonably believed to have been placed intentionally with or near human remains, and are connected, either at the time of death or later as part of the death rite or ceremony of a Native American culture according to the Native American traditional knowledge of a lineal descendant, Indian Tribe, or Native Hawaiian organization. The unassociated funerary objects have been identified by a preponderance of the evidence as related to human remains, specific individuals, or families, or removed from a specific burial site or burial area of an individual or individuals with cultural affiliation to an Indian Tribe or Native Hawaiian organization.

- The 45 objects of cultural patrimony described in this notice have ongoing historical, traditional, or cultural importance central to the Native American group, including any constituent sub-group (such as a band, clan, lineage, ceremonial society, or other subdivision), according to the Native American traditional knowledge of an Indian Tribe or Native Hawaiian organization.

- There is a reasonable connection between the cultural items described in this notice and the Wilton Rancheria, California.

#### Requests for Repatriation

Additional, written requests for repatriation of the cultural items in this notice must be sent to the authorized representative identified in this notice under **ADDRESSES**. Requests for repatriation may be submitted by any lineal descendant, Indian Tribe, or Native Hawaiian organization not identified in this notice who shows, by a preponderance of the evidence, that the requestor is a lineal descendant or a culturally affiliated Indian Tribe or Native Hawaiian organization.

Repatriation of the cultural items in this notice to a requestor may occur on or after May 30, 2025. If competing requests for repatriation are received, the University of California, Berkeley must determine the most appropriate requestor prior to repatriation. Requests for joint repatriation of the cultural items are considered a single request and not competing requests. The University of California, Berkeley is responsible for sending a copy of this notice to the Indian Tribes and Native Hawaiian organizations identified in this notice and to any other consulting parties.

**SUMMARY:** In accordance with the Native American Graves Protection and Repatriation Act (NAGPRA), the University of Florida, Florida Museum of Natural History has completed an inventory of human remains and associated funerary objects and has determined that there is a cultural affiliation between the human remains and associated funerary objects and Indian Tribes or Native Hawaiian organizations in this notice.

#### Abstract of Information Available

Human remains representing, at least, two individuals have been identified from the Unknown Name (8SO16), in Sarasota County, Florida. The 196 associated funerary objects are pottery, lithics, shell, and fossilized faunal bone. The site is located in Englewood, Sarasota County, Florida. It is an unnamed site that contains a shell midden that lies on the shore near Palm Grove Ave. This site was excavated by J. M. Goggin. The midden was referred to Goggin by a local, Fred Kruea. This collection was a part of a bulk transfer from the University of Florida Anthropology department in 1971. The artifacts consist of pottery, lithics, and fossilized faunal bone. The Florida Master Site File (FMSF) has the site listed as being subsumed by 8SO23, Paulsen Point site. That site is described as a "rare multi-component midden". Immediately adjacent to the 8SO16/8SO23 site is Paulsen Cemetery 8SO1360, a prehistoric cemetery site.

#### Cultural Affiliation

Based on the information available and the results of consultation, cultural affiliation is clearly identified by the information available about the human remains and associated funerary objects described in this notice to be associated with the Seminole Tribe of Florida.

#### Determinations

The University of Florida, Florida Museum of Natural History has determined that:

- The human remains described in this notice represent the physical remains of two individuals of Native American ancestry.
- The 196 objects described in this notice are reasonably believed to have

been placed intentionally with or near individual human remains at the time of death or later as part of the death rite or ceremony.

- There is a connection between the human remains and associated funerary objects described in this notice and the Seminole Tribe of Florida.

#### Requests for Repatriation

Written requests for repatriation of the human remains and associated funerary objects in this notice must be sent to the authorized representative identified in this notice under **ADDRESSES**. Requests for repatriation may be submitted by:

1. Any one or more of the Indian Tribes or Native Hawaiian organizations identified in this notice.

2. Any lineal descendant, Indian Tribe, or Native Hawaiian organization not identified in this notice who shows, by a preponderance of the evidence, that the requestor is a lineal descendant or an Indian Tribe or Native Hawaiian organization with cultural affiliation.

Repatriation of the human remains and associated funerary objects described in this notice to a requestor may occur on or after May 30, 2025. If competing requests for repatriation are received, the University of Florida, Florida Museum of Natural History must determine the most appropriate requestor prior to repatriation. Requests for joint repatriation of the human remains and associated funerary objects are considered a single request and not competing requests. The University of Florida, Florida Museum of Natural History is responsible for sending a copy of this notice to the Indian Tribes and Native Hawaiian organizations identified in this notice.

#### Abstract of Information Available

A total of one cultural item has been requested for repatriation. The one object of cultural patrimony is a willow conical basket with a leather tip. Despite an exhaustive search of available records, no documentation has been found regarding its geographical origin, collection history, acquisition details, or other relevant information about the basket. As a result, we consulted with Dr. Jan Timbrook, a basketry specialist, to examine the object. Dr. Timbrook provided her expertise to help identify potential culturally affiliated Tribes based on the basket's style, type, and materials. She concluded that the willow conical basket with a leather tip may have originated from the Arizona region and could be associated with either the Havasupai or Paiute Tribes.

#### Determinations

California State University, Los Angeles has determined that:

- The one object of cultural patrimony described in this notice has ongoing historical, traditional, or cultural importance central to the Native American group, including any constituent sub-group (such as a band, clan, lineage, ceremonial society, or other subdivision), according to the Native American traditional knowledge

of an Indian Tribe or Native Hawaiian organization.

- There is a reasonable connection between the cultural item described in this notice and the Havasupai Tribe of the Havasupai Reservation, Arizona.
